Treasurer's Report and Financial Reports

Greetings Northminster Community!

This is the first annual report I've made as your fully installed Pastor and let me first express my gratitude to the Pastor Nominating Committee for their hard work and diligence across their year-long process. It was a true honor to serve as your Transitional Pastor and I am excited as we continue our journey as a community together.

This past year has been one of profound faithfulness. As a community, we strove for a balanced budget and got there! We welcomed two new staff members, Joseph To as Director of Music, and Dustin Wilsor as Director of Ministry. Both have enriched and enlivened Northminster in so many creative ways and we feel blessed to work with them.

In connection with the Seattle Presbytery, NPC joined the Thriving Congregations Cohort, and a dedicated team of folks have been attending trainings and workshops examining how we understand our past, present, and future in the community we call home. This work has spurred Session to create a new, part-time Associate Pastor of Development role that begins January 1st. Elder Martín Jiménez, who has been certified for ordination in the PC(USA), has accepted this year-long, temporary position and will be leading a team who will evaluate the state of our building in terms of short and long-term repairs needed, as well as how we can best put our building to use within the community.

One of my goals as we came out of the Covid-19 pandemic was to see the building in active, daily use because the space we steward is one of our greatest assets to our neighborhood and broader community. We currently are home to two youth sports clubs that use our gym for weekly practices, daily AA meetings, a preschool, daily homeless shelter, and music rehearsal/performance space for a few different ensembles. We get more inquires for space than we can meet, so we are keenly aware of the great need for meeting and gathering space in the community that is inviting and affordable for these non-profit groups.

What has been even more inspiring is that these groups see us as partners in the community and frequently ask me how they or their families can help serve this community and support the space. We have also made connections with other area churches, looking to see how we can better partner to serve an even broader network of people.

This Christmas season, a question from Dan White Jr., an author who writes about the changing church and its future, made the rounds on social media. He asked, "Would we go to Church if it was just a bunch of ragamuffin Jesus-followers gathering around a table, trying to love God and love neighbors?"

What better questions could we be asking ourselves in this age of deep divide and shrinking church sizes? We are in the midst of a reformation away from the Church as a commodity to be consumed and returning to the Way of Jesus, which was how our faith communities began thousands of years ago. I have not only been blessed to hang out with all you ragamuffins, but I've seen you come together in service, in prayer, in worship, and in fellowship where the only point was to share the love of God with one another and with our neighbors.

That is why I know we are a thriving community with a bright future. Thank-you for letting me be a part of your journey!

Director of Ministry Report, 2023

I came into the role of Director of Ministry in June of 2023. My duties include but are not limited to the following: administrative tasks, youth programming, worship assistance, and community outreach.

The focus of the work that I have done in these six months has been to make worship feel inclusive to our youngest worshipers. I have created a special Kids' Bulletin that helps explain to young readers what is happening during a worship service and why we observe worship the way we do. It also provides space and suggestions for how they might engage with the prayers, songs, and stories that they are experiencing. In addition to these special bulletins, I also provide other worship resources that are connected to the themes and stories of worship including coloring pages, word searches, prayer/meditation prompts, etc.

These things all aid in bringing the children alongside the adults during worship, but I have also striven to bring adults alongside the children during worship as well. Changing the name of "Children's Moment" to "Stories for All" highlights the idea that there are lessons for us all to learn throughout all of worship. Focusing on a time in worship that is specifically for kids implies that adults can check-out for this part and that the rest of worship isn't really for the kids. I don't believe either one of these things is true. While the change in name has largely been symbolic at this point, I have slowly begun to incorporate our grown-up listeners into this time as well, and I have hopes to expand and strengthen the ways that we do this in the year-to-come. This year's no-rehearsal Christmas Pageant is a good example of what I would love to see our community of intergenerational worshiping can look and feel like with each member ministering to and alongside each other at the same time in joy and love.

I also introduced the occasional time within worship for responding to the message. This has been a ritual-based response to the message that is intended to encourage worshipers to embody the message of the sermon. These activities have typically been intentionally intergenerational in design, providing another opportunity for generationally equitable worship. These ritual-based meditation practices have also provided the basis for Sunset, the monthly contemplative services that I started leading in October. These have incorporated visual art, poetry, music, prayer, and ritual into an evening of shared meditation among a small group on the last Wednesday evening of the month.

Finally, I led Northminster's involvement in the Subversive Saints of Seattle art project, bringing together the communities of Newport Presbyterian Church, St. John's United Lutheran Church, Woodland Park Presbyterian Church, Northminster Presbyterian Church, and Coastland Commons in a united community art project exploring and celebrating everyday heroes from Seattle's history. Half of this collection hung in the Library during Advent 2023, and the second half will hang in the Library during Lent 2024.

2023 has been a good year for worship and music at Northminster.

Hybrid worship continued with the average attendance for Sunday morning is 58, which includes an average of 12 people participating via Zoom.

Throughout 2023, Pastor Jeny Carlson used **Year W: A Woman's Lectionary for the Whole Church** by Rev. Dr. Wilda C. Gafney as our lectionary base to provide insightful and inspiring sermons. Dustin Wilsor, Directory of Ministry began leading monthly Sunset services — a time for contemplative meditation through scripture, readings, music, ritual, and prayer.

Joseph To began as our new Music Director in September. Prior to Joseph's arrival, Becky Rufin graciously filled in to lead the choir.

The Bell Choir has continued to perform beautiful music for the congregation, including performing on Christmas Eve morning. Joseph To has performed solo performances throughout the year. Liang Chen, our accompanist, and his wife, violinist Junheng Chen, have performed together and Junheng has also performed violin duets with Beth Schmidt. Beth Schmidt has also performed duets with cellist, Lori Vanderbilt. Aquila Wu and Rachel Wu continue to bless us with their violin playing.

In June, the Worship and Music committee decided that the choir was no longer required to wear masks while singing.

Local musical groups and music teachers continue to express interest in using our sanctuary as a practice and performance space. To accommodate these groups, the church will be adding casters to the piano, so it can be moved more easily.

Ali Dahmer created beautiful new paraments for the sanctuary. Ali also repaired Advent paraments created by Ann Wightman.

With Dustin Wilsor, Director of Ministry's guidance, church youth made snowflakes to decorate the sanctuary for Advent and beyond.

Nancy Ingle, Szu-Yu Huang, Katie Tynan, Carol Charles, and others supplied seasonal flower arrangements for the sanctuary.

PERSONNEL COMMITTEE 2023

On July 9, 2023, Northminster joyfully called Jeny Carlson to become our installed Pastor, following the recommendations of the Pastor Nominating Committee (PNC). Jeny was installed on August 13. This committee is grateful to the PNC for their yearlong discernment work, and we warmly congratulate Jeny on this major life milestone.

Other important transitions this year:

In March we were very pleased to welcome Joseph To as our Music Director. Joseph, a Hong Kong native, is an award-winning music director, educator, world music advocate, and adjudicator who focuses on connecting people and communities through music. Northminster is very fortunate to have someone with Joseph's skills and love of music leading our music program.

Also in March we said goodbye to our beloved Director of Ministry, Adelia Nunn, as she began her next steps in her path toward ordination in the Methodist Church.

In September, the Committee recommended creation of a new position of Temporary Associate Pastor of Development. The main purpose of this part-time position (5 hours per week for one year) is to lead a team of elders and members beginning January 1, 2024, with the goal of preparing recommendations to Session and the congregation by year-end 2024 concerning use and development of church physical assets. This effort was initiated to aid in navigating

Northminster through the profound challenges facing all mainline churches. The new position was approved by the Session and Presbytery's Committee on Ministry. Martin Jiménez will serve in this position, which will require his departing the Session and this committee. We are very grateful for the hard work and the kindness and depth Martin has contributed to this team's efforts and look forward to working with him in his new capacity.

In October, Dustin Wilsor was appointed as Director of Ministry. The main tasks of the Director of Ministry at Northminster are to (1) collaborate with the Pastor in fostering the spiritual development of the intergenerational community that is our congregation, (2) partner in creative ways with local organizations in support of the wider, extramural community, (3) assist with communications of churchwide and church-related activities, and (4) serve as a worship leader in coordination with the Pastor. Dustin brings to this position outstanding creativity, energy, and communication skills. Dustin is on the ordination track in the (PCUSA) under care of Woodland Park Presbyterian Church, and additionally serves as Gatherings Coordinator for Coastland Commons, our partner faith community.

The staff under the guidance of Jeny Carlson is working well together. We look forward to a positive and productive 2024.

BUILDING & GROUNDS 2023

It has been a productive year for B&G committee as we have made progress on some deferred maintenance across the campus, assessed some of our aging systems and started to get a handle on ongoing maintenance in our post-lockdown reality.

The committee consists of Martin Jiménez (Chair), Pastor Jeny Carlson, Lars Carlson, and Sarah Timmons.

First some of our big and exciting accomplishments both done in partnership with our gardening committee:

- 1. We successfully contracted with Monsoon Rain Gardens to install AT NO COST a rainwater retention system. The parts and labor of this would have gone into the tens of thousands of dollars but it was completely free as part of the city's rainwise program. During the winter our "large roof" campus dumps rain into 5 large cisterns that fill up while slowly discharging the storm water into the city sewer. This helps to buffer what the city's combined sewer must deal with in particularly heavy storms and helps us attend to our flooding problems.

 Additionally in the spring we can allow the cisterns to fill and hope to make
 - Additionally in the spring we can allow the cisterns to fill and hope to make a large savings dent in our garden watering bills during the summer.
- 2. Another project was the planting of the maple tree in the manse parking strip in memory of Signa Treat, former Deacon and Elder and member of Building & Grounds Committee who passed away in 2023. While there is still work to be done to add more landscaping to that strip, the planting of the tree felt honoring to a beloved congregation member and a nice addition to the public experience as it grows to provide shade and beauty.

Additional tasks that were accomplished:

- 1. Manse. An extensive cleanup of the manse yards with a number of mitigation efforts to keep future maintenance at a more manageable level. We also got picked for a City of Seattle rental inspection and passed inspection except for the stairs and deck and the placement of smoke and CO2 detectors. That has been rectified and a new inspection is scheduled. Some plumbing issues were resolved and the heater has been serviced to continue to keep our current tenants, Maya and Lance, cozy. Once Jeny was called and it was clear that we didn't need the Manse for a pastor's residence, Maya and Lance agreed to sign a lease through 2024 with a slight adjustment to \$2800/month, utilities included, which seems to be a good deal given the size and amenities of the property. We encourage you to be friendly as you encounter them as the sun gets warmer, as we hope to keep nurturing their goals and dreams in the little ways we can.
- 2. **Sanctuary.** Besides the usual maintenance items of changing lightbulbs and fixing urinals, we have embarked on a few modernization projects. We purchased a set of scaffolding so that we could address difficult to access lightbulbs in our chancel. Upon further inspection the fixtures are

probably suffering from some end-of-life issues. The difficulty of access and outdated lighting design in a "Zoom era" probably means spending a bit of money in the future to install higher quality and more easily accessible and controlled lighting in the near future.

For Sunday morning we have some new traffic calming "kids playing" figurines we can put out on Sunday morning to help drivers have better awareness, and we have reinstalled the handicap parking signage in front and repainted the curb to allow for our less-abled church members to assure easy access to the sanctuary on Sunday mornings.

3. **Safety.** Our water heaters and boiler have largely passed inspections with a few things that need to be adjusted this year to bring ourselves into better compliance. We have added some exterior lighting and updated our security camera systems and some door access points such as the Fellowship Hall closet and Office with internet enabled coded door locks with finger-print recognition.

Another safety concern was our old-style blinds that are a choking hazard for young kids. We are in possession of new blinds that will both update the space and be reassuring for the families with young kids who have started to attend, bringing a little welcome rambunctious energy to the balcony.

3. **Future projects (the plumbing).** It came to the attention of the committee in November that what we thought was a manageable issue with our plumbing is in fact a little more dire. To begin to address that we have begun reaching out to commercial plumbing companies to get quotes on replacing sections or the entire run of plumbing from the bathrooms under the Gym past the Kitchen and Fellowship Hall (and those bathrooms) and into the street, with a tree on the sidewalk whose roots already enjoy it's nourishment. We hope to have a few bids by midwinter so we can approach the Session with a plan to address the issue.

BOARD OF DEACONS 2023

The Deacons are the church leadership group in charge of the caring ministry of the congregation. As such, they provide support to members of the Northminster community as well as those in need in the local community. During 2023, the Deacons were involved in this ministry in many ways.

Support of congregation members and friends:

- -Deacons provided many meals, rides to doctor appointments, visits, phone calls, cards, and prayers for those with health or other needs.
- -Lisa Lady sent cards in recognition of members' birthdays and led a session for the deacons to make handmade cards to send.
- -Deacons took in-home communion to members who were unable to take Communion in-person on Sunday mornings.
- -The Deacons purchased copies of The Upper Room for use for daily devotions by our community members.
- -Many of the Deacons helped with the Friendship Group events- the luncheon in June and the Christmas Tea in December.
- -Our bimonthly meetings included time for sharing concerns about and prayers for community needs as well as devotions, mutual support, and fellowship for deacons themselves.

Recognition of Caregivers:

We mailed handwritten cards to recognize the dedication and important work of many wonderful people in our congregation who are caregivers for family members or whose vocation is providing home care and support for people in the community with medical needs.

Contributions to Sunday worship:

Deacon Nancy Ingle provided many beautiful flower arrangements for Sunday morning worship. Jennifer Jensen faithfully prepared Communion elements and helped serve the Elements for many worship services.

Leadership on special congregational committees:

Thanks goes to Dawn Thornhill who put in many hours serving on the Pastor Nominating Committee.

Support of local community through the Deacon Fund and special drives:

The Deacons sponsored a donation drive for Ballard Food Bank during Lent. The congregation generously donated many highly needed items, including baby diapers and personal hygiene items, and \$415 in cash donations. Liz Tennant delivered these to a grateful Ballard Food Bank.

Church Clean-up: We shared lunch together and then ticked off the jobs that made our church sparkle.

Fiber Arts Group: A group brainstormed the idea of getting together Saturday mornings and working on various individual projects that lend themselves well to coffee and conversation, from knitting to card-making, to mending clothes, to whatever project calls for hearts and hands.

We look forward to more opportunities to gather, share, and grow in 2024. Thank you to the entire outreach team for their engaging and sustaining work.

ENGAGEMENT AND STEWARDSHIP "BEYOND OUR WALLS" 2023

Over several months, with Session's blessing, the Beyond the Walls Team looked for ways in which Northminster could be meaningfully engaged in relief and development efforts around the world, and ultimately decided to partner with the Presbyterian Church in the Democratic Republic of the Congo and the Presbyterian Community of Kinshasa to help the Congolese people improve their lives. The DRC is one of the poorest nations in Africa. We are working with Congo Mission staff and the community to learn what will be most helpful to the people

of the Congo. We have been told that some of their greatest needs are to build and equip schools and train teachers.

On Sunday July 16th, the Beyond the Walls Team sponsored a special coffee hour to support a local Congolese immigrant business and to continue learning and engagement with the **Democratic Republic of the Congo (DRC).**

After researching local groups that help Central American refugees and immigrants, we recommended to Session that that we support the **Safe Route Immigration Program** offered by **Lutheran Community Services Northwest** (**LCSNW**), **Refugee and Immigrant Services**. This program provides accessible legal services to refugees and immigrants in the Pacific Northwest. Session approved this partnership and designating Northminster's share of the PC-USA's annual Peace and Global Witness Offering to this Program.

During 2023, Northminster members participated in four special offerings and gave as follows:

- One Great Hour of Sharing \$504
- Pentecost \$3,512 (see details below)
- Peace and Global Witness Offering \$951 (see details below)
- Christmas Joy \$417 which supports the education and development of youth of color and special grants for those who serve or previously served PCUSA congregations

In addition, Northminster members and friends gave \$1,400 for response to the Syria-Turkey Earthquake and the Beyond Our Walls (BoW) team released prior year funds to add another \$2,000 for a total of \$3,400. The BoW team donated \$1,500 from prior year funds, including from a tithe of bequests, to address extreme hunger in Central Asia. Stewardship assisted in collecting and passing along funds for Path from Poverty, an organization empowering women and girls in Kenya, supporting both the Walk for Water and the Harambee fundraising dinner event.

From the Pentecost offering of \$3,512 we gave \$2,107 for national programs for youth and young adults. In addition, \$1,405 from the offering plus \$2,095 from BoW funds (total \$3,500!) was given to support educational programs in the

District of Kinshasa in the Democratic Republic of Congo. Presbyterians are active in education in this nation!

For the Peace and Global Witness Offering, 50% (\$475.50) goes to PCUSA National peacemaking efforts and 25% (\$237.75) to Seattle Presbytery's efforts. BoW added \$262.25 to the \$237.75 share that Northminster designated to Lutheran Community Services Northwest for Immigrant and Refugees Services, particularly for assistance to those from Central America.

In 2024, be ready to engage in greater depth with these global and global-local connections! We have "beyond our walls" funds on hand that can be designated for global (or local) ministry partnerships.

BUDGET, FINANCE, MEMORIALS AND STEWARDSHIP COMMITTEE

This committee helps coordinate the work of the Financial Secretary and the Treasurer and also invests the church's funds so that they're available when needed.

Stacy Kern finished an excellent run as Financial Secretary, tracking pledges and making sure donations are attributed to the correct people and that the giving reports get sent out each year. We are very grateful for her many years of service! **Szuyu Huang** has taken over and quickly assumed management of the pledge/donation system. **Becky Rufin** continues as an outstanding Treasurer! Her separate reports accurately convey our financial situation and show the detail with which our finances are tracked. **Jonathan Bowdler** serves as our crucial link to Session. Thank you, Jonathan!

Our major initiative this year was to review the way our financial reserves are invested with the goal of taking advantage of current higher interest rates. This involved moving money from no-interest checking and some of the Pickell

bequest funds to a ladder of FDIC-insured CDs yielding over 5%. The increased interest income has a salutary effect on the 2024 proposed budget. With **Rodney Schmidt's** and **Jonna Reeder**'s combined expertise, we continue to review other investments so that we're sure to have adequate emergency funds and to better align the remaining investments with the goals of our congregation.

ANNUAL TREASURER'S REPORT, 2023

Northminster Presbyterian Church began 2023 projecting a net yearend deficit in our General Operations budget of nearly \$33K, even after transferring \$16K from our reserves and assuming we would receive a \$5K relief grant. We put faith in God and ourselves that we would continue to flourish and grow despite our budgetary challenges.

I am therefore pleased to report that at the end of 2023, we actually have a slight budgetary surplus of \$1,523, even after returning the \$16K transfer back to our reserves.

As can be gleaned from a close examination of the Table 1 General Operations Fund Report, this amazing financial turnaround can be observed in several line item categories. These warrant further explanation, as follows:

- 1. We received 32 pledges in 2023 for a total of \$135K, and actually gathered \$133K from the pledging households, nearly 99%! In addition, we received over \$63K from non-pledging households, including several generous one-time gifts. Altogether, the church received over \$16K more than originally projected in this income category.
- 2. We have reconfigured our various investments to leverage far better interest and dividend returns. Therefore, our income in this budget line item was substantially higher than projected for the year, and we are expecting that trend to continue, as shown in our 2024 budget projections. Many thanks to Rod Schmidt and Jonna Reeder for spearheading these efforts.
- 3. Our property insurance rates have been skyrocketing the last several years, leading us to look into other options. By taking the calculated risk of

eliminating earthquake coverage (the primary driver of the high rates) and seeking a new provider, we were able to reduce our insurance premiums somewhat in 2023 and will have far greater savings in 2024. Many thanks to Carol Charles for leading this effort.

- 4. We had two vacancies the first half of the year Director of Music and Director of Ministry. When Dustin was hired, it was only for 15 hours/week versus the 25 hours/week budgeted for his predecessor. These unplanned staffing changes substantially reduced our payroll-related costs by about \$20K. We move into 2024 with full staffing, so this expense reduction is not likely to recur in 2024, nor do we actually want "savings" in that form.
- 5. We budgeted for 8 hours/week custodial services at \$25/hr, however, in practice we have only been utilizing such services for about 4 hours/week. This saved over \$5K in payroll costs in 2023, and we are budgeting for 5 hours/week in 2024.

Meanwhile, the Table 2 Statement of Financial Position shows that our overall assets have increased by about \$20K in 2023. This is due to the steady recovery that occurred in the stock market, as well as the reconfiguring of our financial assets mentioned above.

Despite our unanticipated success in 2023, we don't expect that trend to continue into 2024, and indeed we currently project a budget deficit of over \$27K. Our 2024 pledge drive garnered a total of 27 pledging households for a total of \$134,400, slightly down from 2023. We do not anticipate any relief grants, but we do expect full staffing the entire year, including our new Director of Formation. Furthermore, we want to support our staff, so have budgeted for 3% COLA increases for all staff in 2024.

Our hope is that with our new permanent Pastor Jeny, we can fully focus on programs and ministries that support our congregation and our community, which may attract new members who will add their financial support in future years, thus allowing Northminster to grow and thrive.
